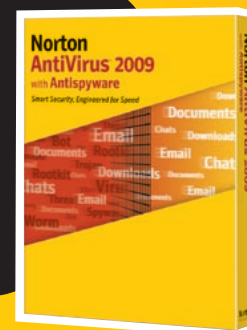

- 3. Enclose the original UPC code** from Norton AntiVirus 2009. The UPC code is a 12-digit bar code found on the bottom of box. Photocopies will not be accepted. If you downloaded this product, your confirmation email from your download purchase will serve as your UPC code.
- 4. Enclose** a legible copy of your dated sales receipt(s) with the purchase price circled of both Norton AntiVirus 2009 and any version of TurboTax from Intuit or TaxCut from H&R Block. Products need not be purchased on the same receipt. Copies of both receipts required for submission. Handwritten or altered documents will not be accepted. If you have downloaded any of these products or purchased them online, your dated sales receipt is your confirmation email from your online purchase. Sales receipts for Norton AntiVirus 2009 from Best Buy, BJ's Wholesale Club, Circuit City, Costco, OfficeMax, Sam's Club, Staples, Target, and Wal-Mart are not eligible.
- 5. Make a copy** of your rebate submission for future reference. Originals submitted become Symantec property and will not be returned.
